

COOPERATION AGREEMENT

BETWEEN

***UNIVERSITY OF TURIN
(Department of Physics)
ITALY***

AND

***UNIVERSITY OF HADJ LAKHDAR BATNA
(Department of Science of Matter- Faculty of Science)
ALGERIA***

The University of Turin -Italy-, represented by the Rector, Prof. *Gianmaria Ajani*

And

The University of Hadj Lakhdar Batna -Algeria-, represented by the Rector, Prof. *Tahar Benabid*

In order to establish and maintain scientific research and teaching relationships between the two Institutions, make preliminary agreements for an exchange program between teachers and researchers and integrate scientific research and teaching activities.

Art.1

The university of Turin, Department of Physics, Italy

and

the University of Hadj Lakhdar Batna -Algeria-, / Department Of Science of Matter- Faculty of Science, hereinafter referred to as the Institutions, agree upon a co-operation on the following topic: **Astrophysical fluid dynamics.**

The persons in charge of the program will be:

Prof. *Silvano Massaglia*, Faculty /Department of **Physics** of the University of Turin, Responsible of the Italian side.

Prof. *Abdelhamid Bouldjedri* .Faculty/Department of *science of matter* University of Hadj Lakhdar Batna, Responsible of the Algerian side.

Art.2

For the fulfillment of these investigations the Institutions agree to deepen their collaboration in the following ways:

- by carrying out joint research projects.
- by exchanging academics, researchers, technical-administrative staff and other specialists, students;
- By free admittance to the libraries and free access to the research facilities existing in the participating Institutions;
- Participation to conferences, symposia, congress with scientific papers;
- by exchanging scientific information and materials on conditions agreed upon;
- by joint publications of the results obtained in joint projects;
- by any other kind of co-operation that may prove useful to achieve the joint objectives.

The program could be increased and modified according to the common requirements and to the development of the undertaken research.

Exchange of students has to be defined in specific additional protocols.

Art. 3

Within the limits of regulations in force in each country, the parties agree to find the financial means necessary to reach the above mentioned objectives. The expenses will be jointly identified and will be charged to the department/laboratory directly involved in the present agreement, unless specific funds from private or public institutions are available.

The parties agree to give the logistic support to the visitors.

Art. 4

Each person involved in all foreseen activities of this agreement has to provide himself with a suitable insurance covered by the institution of the origin.

To the academics, researchers and students that will benefit from this protocol will be ensured medical assistance, in the limits of the agreements concerning the reciprocal guarantees and assistance existing between the respective countries.

Art. 5

Unless otherwise agreed, the parties will jointly own the technological and scientific results obtained within the present cooperation program. They undertake to protect and exploit them. According to the industrial laws and regulations in force in both Institutions. In order to permit an easier negotiability of the results obtained, each party undertake to prevent any claim of rights by its personnel or by persons in contact with the Institution.

Art. 6

The present agreement will be of 5 years duration, starting from the date of the last signature by the Rectors of the contracting Universities and after the approval of the competent academic authorities. Any modification of the present agreement requires the written approval of the parties.

The present agreement could be renewed subject to the written approval of the academic authorities. In the case of decision not to renew the agreement, the pattern of the exchanges within the final year of the agreement shall be such as to equalize exchanges over the entire period of the agreement.

Art. 7

The present agreement comprises equivalent texts, in English and Italian. They will be kept in each Academic Institutions.
